### TERMS AND CONDITIONS

- 1. The scrap materials as in Annexure-I is offered for disposal on "As is Where is Basis".
- 2. The bidders are required to quote the rate strictly as per the terms and conditions mentioned in the Tender document. The conditional tender will not be entertained and shall be liable for outright rejection.
- 3. Bidders must have a registered firm having a valid GST registration No., PAN No., Aadhar card and Address proof etc. All the relevant document should be uploaded on GeM portal. The original copy of the document of the bidder can be demanded by the office at any stage. Address should be completed and supported with proof (copies of Aadhar/Voter ID/Passport)
- 4. The bidders should quote the amount for both in words and in figures, if there is any difference between the amount mentioned in figures and that of in words, the rate quoted in words will be taken into account and accepted on record.
- 5. Offered/Quoted price (Rs.) should not be less than the reserve price fixed but can be more than reserve price. The order will be awarded to the highest bidder on receipt of quote which is more than reserve price. The bidder has to pay GST amount of 18% over and above the reserved quoted price.
- 6. Any modification in offer after the closing of tender will not be considered.
- 7. The successful bidder will have to pay the full quoted amount including 18% GST, within seven days from the date of award of order by making payment in the form of Demand Draft issued by the any Nationalized Bank in favour of "Pay & Accounts Officer, MoH&FW, Chennai 90".

The successful bidder shall lift the entire scrap, as in Annexure-I, by deploying their own labour and machines at their own cost from the place where the items are lying, taking all safety precautions within 10 working days from date of acceptance of order after making the payment of the quoted amount.
- 9. No extension of time lime stipulated in condition will be granted under normal circumstances. However, if the successful bidder desires an extension due to unavoidable circumstances in the execution of acceptance order, he shall apply in writing within a period of five days of the date of such circumstances to "the Director, BCGVL, Chennai and if in his opinion (which shall be final) is satisfied about the reasonableness of the grounds may grant any such extension of time as may be necessary, proper and binding on the purchaser.

- 10. Any statutory or other charges shall be borne by the bidder.
